If you use the cash method of accounting, deduct the salary or wages paid to an employee in the year you pay it to the employee. If you use an accrual method of accounting, deduct your expense for the salary or wage when you establish your obligation to make the payment, when you can determine the amount of the obligation with reasonable certainty, and when economic performance occurs.
